GENERAL INFORMATION

SPECIFIC COURSE INFORMATION

Compulsory zero (0) credit point units/programs/modules: MAI010 Academic Integrity (0-credit-point compulsory unit) to be completed in first Trimester of study.

MLM070 Academic Induction for Professional Accounting and Law - Online Induction is compulsory for all students. The Induction is available at Cloud Course Site. All students must complete the online induction on foundations of law within the first trimester of their enrolment. Upon successful completion of the induction, student services are automatically notified and students receive an acknowledgement of their completion of induction.

The Master of Professional Accounting and Law is typically 8, 12 or 16 credit points. The exact number of credit points you study depends on how much credit you receive as recognition of prior learning (RPL) - your professional experience and previous qualifications.
