# **OPEN RESEARCH POSITION STATEMENT**

#### Introduction

At the Open Access (OA) Roundtable held in March 2024, participants considered and endorsed 15 preliminary policy clauses that were designed to inform future policy work. Deakin's University Librarian subsequently worked with Director, Academic Governance and Standards to transform the detailed clauses into a high-level Open Research Position Statement to guide decision making and prioritisation of work by the OA Taskforce.

## **Deakin's Draft Open Research Position Statement**

The draft Position Statement includes four Foundational Principles and six Institutional Commitments.

#### Foundational principles:

- Research is global public good, and barriers to the dissemination of research should be removed wherever possible
- 2. Open research practices are aligned with Deakin's values and strategic ambition of driving positive societal impact
- 3. Open research practices foster trust, transparency, and integrity in research
- 4. Urgent reform is needed to create a more sustainable, affordable and scholar-led research ecosystem

#### Institutional commitments:

- 5. Deakin actively supports and contributes to global open research initiatives that seek to reform and transform the scholarly publishing system
- 6. Deakin researchers will publish as openly as possible, adhere to <u>FAIR</u> and <u>CARE</u> principles, and consider the ethics of publishers with which they work
- 7. Deakin supports multiple pathways to open dissemination of research
- 8. Deakin supports CAUL's efforts to negotiate open access agreements and encourages researchers to make full use of these agreements. Deakin does not support the payment of Article Processing Charges (APCs) to make a single article open in an otherwise subscription journal
- 9. Deakin is prepared to cancel publisher agreements where they do not align with Deakin's commitment to sustainable and affordable open research
- 10. Deakin is committed to optimising policies, services, and systems to accelerate open research practices, including reward and recognition and research quality evaluation

### **Operational Implications**

The table in Appendix A cross-references the new Position Statement clauses with the original clauses discussed and endorsed at the OA Roundtable, and provides a summary of operational implications for implementation.

#### Recommendation

This paper recommends that Deakin's OA Taskforce:

- Endorse the draft Open Research Position Statement
- Provides feedback on the identified operational implications (Appendix A)
