D335 COURSE FuleS - In order to qualify for the award of Bachelor of Criminology/Bachelor of Laws (D335), students must complete 40 credit points, which must include the following:

16 credit points from the Bachelor of Criminology (A329), including;

At least 12 credit points of ACR coded units, including 6 core units (at least 6 credit points at level 3 including ACR301 and ACR302);

Up to 4 credit points of elective units from the Faculty of Arts and Education*

24 credit points from the Bachelor of Laws (M312), including;

18 credit points of core units

6 credit points of law elective units, including 1 credit point of an experiential unit from the WIL/Practical Elective units list MAI010 Academic Integrity

(0-credit-point compulsory unit)

GENERAL INFORMATION
